### **Donor Advised Funds (DAFs)**

a process administered by the Philadelphia Foundation to manage charitable donations on behalf of organizations, families, or individuals.


### **Discretionary Grantmaking**

a process where Philadelphia Foundation staff exercise judgment (discretion) in selecting the grant recipient organization through a competitive process.

<u>Special Initiatives and Grants Management</u> – Philadelphia Foundation staff play varying roles in receiving and managing grant applications for funds which the Foundation administers in partnership with other groups. (for example, Henrietta Tower Wurts Memorial)

# **Discretionary Grantmaking Categories**

PHILADELPHIA FOUNDATION

## **Direct Service/General Operating Grants**

Unrestricted grants available on a competitive basis for well-run nonprofits serving communities with high poverty rates while operationalizing equity at all levels of their work. 2023 Direct Service Application

### **Impact Program Grants**

Program grants available to nonprofits demonstrating programmatic impact. 2023 Impact Grant Application

## **Leadership Grants**

Project grants available on a competitive basis to increase measurable skills and racial diversity of pipelines for senior staff and board of nonprofits; and to strengthen organizational capacity and nonprofit leaders in the areas of governance, planning, civic engagement, board and staff development and diversity, equity and inclusion. 2023 Leadership Grants Application

# **Discretionary Grantmaking Categories**

## **Advocacy Unrestricted Grants**

Unrestricted grants available to organizations addressing policy changes in relation to racial and social justice. Emphasis on utilizing advocacy and community organizing best practices towards policy change on behalf of marginalized and low-income communities in Greater Philadelphia. 2023 Advocacy Unrestricted Application

## Fund for Children Strategic Investment in Youth Grants

Unrestricted grants for Philadelphia-based youth organizations whose missions prioritize youth leadership, civic engagement and youth organizing activities and outcomes. 2023 Fund For Children Strategic Investment in Youth Application

## **YOUTHadelphia Grants**

Program or Project grants to youth organizations that include social and political themes and content, and help young people develop skills and capacity to be decision makers and action-oriented problem solvers. Emphasis on youth-led work.

- Must be a 501(c)3 or Fiscally Sponsored organization serves Greater
   Philadelphia (Bucks, Chester, Delaware, Montgomery, & Philadelphia counties in PA and Burlington & Camden in NJ)
- If fiscally sponsored by a 501(c)3 nonprofit, applicant must have an advisory Board separate from its fiscal sponsor's Board
- Must employ at least one full time equivalent staff person
- Organizations must support BIPOC and other historically marginalized and under-invested communities, with at least 70% of participants qualifying as low income
- Statewide or national organizations must demonstrate at least 75% of budget raised locally and have an advisory board in the service area
- Cannot have deficits greater than 10% of operating budget in the past year.
- Organizations may only submit one application for Discretionary Grants per calendar year. Applicants may apply for only one grant bucket, either Direct Services, Impact, Leadership, Advocacy, or Fund for Children.

# Eligibility to Apply (continued)

## For Fund for Children & YOUTHadelphia

- Sole focus on significant services to children and youth up to age 18
- Programs must be based in Philadelphia and serving children and youth in Philadelphia
- 70% of the youth served are living in the lowest income and most underresourced communities in Philadelphia

# **Ineligible Organizations**

- Are not located in or serve a constituent base outside of the geographic area served by PF
- Cemeteries
- Umbrella funding organizations
- Schools (K through 12)
- Colleges and university academic or organizational (general purpose) departments
- General childcare agencies
- Government agencies
- Libraries
- Programs housed in universities that raise less than 75% of their funding.
- Local chapters of national organizations that raise less than 75% of their funding.

# **Common Elements Across All Discretionary Grants**

# Responsive to Community

- Deep knowledge and connection to targeted population(s)
- Ongoing mechanisms to gather input and feedback to shape services

### Transformative Lens

 Services driven by a clear theory of change that connects activities to desired changes with an eye to long-term impact for participants and an understanding of structural factors that may impede success

# Diversity, Equity, and Inclusion

 Action taken at organizational and program levels to operationalize equity, including representation that reflects the community served, creating safe and welcoming spaces, working from an intersectional lens, sharing power in decision-making, and addressing structural barriers

# **Discretionary Grantmaking Advocacy**

- Advocacy Unrestricted Grants are available on a competitive basis for nonprofits utilizing advocacy and/or community organizing best practices toward policy, regulation or legislative change on behalf of marginalized and low-income communities in Greater Philadelphia.
- Successful applicants will demonstrate a track record of identifying community issues of concern and the specific policies reinforcing these issues, implementing activities challenging these policies and practices and a history of making change.
- Greater Philadelphia (Bucks, Chester, Delaware, Montgomery and Philadelphia counties in PA and Burlington and Camden counties in NJ). Organizations must support Black, Indigenous, and people of color (BIPOC) and other historically marginalized and under-invested communities and demonstrate operationalized equity.
- STRONG PRIORITY GIVEN TO: organizations able to demonstrate that at least 70% of those they serve or represent are low-income and are considered marginalized.

# **Discretionary Grantmaking Direct Service/General Operating**

- Organizational Board and Leadership reflect the demographics of the community served, or have made significant strides to increase representation
- Diversity, Equity, and Inclusion (DEI) work that has moved from reflection to action stage, with substantial activity at the governance and management levels
- Recent strategic plan or process underway, ideally that integrates a DEI lens and sharpens the organization's strategic theory of change
- Organizational best practices in use, including focus on being a positive place to work, regularly gathering and responding to participant and partner feedback, and using data to improve and refine services

# **Discretionary Grantmaking Impact/Program**

- For program related activities in nonprofits serving high-poverty populations in Greater Philadelphia
- Applicant demonstrates results-oriented programming including a track record of successes and proven outcomes for low-income communities.
- Successful applicants use trauma informed, strength and racial equity-based policies and practices in program development and deliver.
- **Pilot programs** will only be considered if your organization can demonstrate prior success in delivering outcomes-based programs in the past two years and achieved desired goals for targeted populations.

# **Discretionary Grantmaking Leadership**

- To increase measurable skills and racial diversity of pipelines for senior staff and board of nonprofits
- To strengthen the capacities of nonprofit leaders in the areas of governance, planning, civic engagement, board and staff development and diversity, equity and inclusion
- To support leadership transition and increase the diversity of senior staff leadership
- Typically, a single year of funding for a specific effort it is rare
  to receive leadership support for more than one year. In general,
  we expect to see that the organization has used its existing
  resources (and as appropriate, accessed the Key Skills Hub)
  before applying for this fund.

# **Discretionary Grantmaking Fund for Children**

- The Fund For Children (FFC) was established in 2001 from the lease agreement with the City of Philadelphia: a \$2-million annual investment from the Eagles and the Phillies
- FFC is focused on improving the quality of life for the children of Philadelphia, especially, but not exclusively in high-poverty neighborhoods
- Programs funded through the FFC place a high value on youth voice and youth participation
- Priority is given to organizations able to demonstrate that at least 70% of those they serve or represent live in the most disadvantaged/underresourced neighborhoods



## **All Discretionary Grant Programs**

- Priority funding to organizations led by BIPOC chief executives and/or board chairs
- Organizations operating less than 3 years must provide executive summary of Board approved strategic plan and if available - organization logic model.
- Generally, the Philadelphia Foundation does not use discretionary dollars to support organizations where there are familial relationships across the board and staff.
- The following policies should be in place, as indicated in the Part VI, Section B of the Form 990.
  - Conflict of Interest Policies
  - Whistleblower Policy
  - Independent process with comparability data for determining compensation
  - Providing copy of the 990 to board members prior to filing

# **Application Process** and Supporting Documents

Nonprofits that meet basic eligibility requirements may complete the online application and upload supplemental documents including:

- 501(c)(3) IRS determination letter
- List of Board of Directors
- Most recent Audit (if your organization does not have audits, we will accept your IRS 990 or Profit Loss Statement)
- <u>Current PA Bureau of Charitable Organizations Certificate</u>
- Executive Summary of current strategic plan
- Board-approved Nondiscrimination Policy
- Organizational Budget/Project Budget if specified
- Organizations with Interim ED's Board approved hiring and on-boarding plan for permanent Executive Director.
